

Authors General Guidelines

General Guidelines

- The article must be innovative and the result of research by the author/authors.
- Submission of an article or manuscript indicates that the work has not been published before.
- The journal is committed to maintaining the highest level of integrity in the content published, therefore publication ethics and its principles should be fully respected.
- The author/authors are responsible for the content of the article and the publisher will not be held legally responsible for misconducts or claims.
- The initial acceptance of the article will be notified to the author/s after approval by the editorial board. Subsequently, the proposed article or the manuscript is peer reviewed (Single Blind) by two referees, before electronic publication in the journal.

Submission Guidelines

- Article or manuscript length is between 4000 and a maximum of 6000 words including notes and bibliography. (Roughly, the article must not be less than 10 pages and not more than 14 pages in line with our format).
- Save your file in docx format (Word 2007 or higher) or doc format (older Word versions). Font: Times New Roman; Format 12; Single Line spacing and use the automatic page numbering function to number the pages.
- The list of references should only include works that are cited in the text and that have been published or accepted for publication. Personal communications and unpublished works should only be mentioned in the text.
- Reference list entries should be alphabetized by the last names of the first author of each work.
- Abbreviations should be defined at first mention and used consistently thereafter.
- The article references must be included as footnotes on the same page, in numerical order (1,2,3,...), in the same font as the rest of the text.

- An abstract of 150-250 words is quite required. As a primary goal, the abstract should make the general significance and conceptual advance of the work clearly accessible to the broad readership.
- Please provide 4 to 6 keywords, which can be used for indexing purposes.
- Article or manuscript submitted must be in English and should meet international English language standards or shall be subject to literary and technical edits.
- Please provide the required Author information as follows:
 - The full name(s) of the author(s)
 - The affiliation(s) of the author(s), i.e. University institution, (department), city, (state), country, academic rank, field of study,
 - A clear indication and an active e-mail address of the corresponding author
 - And, preferably a mobile phone number of the author/s, along with the full text of the article via email to the Secretary and coordinator of the journal at namchred@ymail.com.
- Receipt of further required format and submission details are available through the Secretary and coordinator of the journal at the same address.
